Township Committee Meeting on Nov. 30

The Township Committee held a regular meeting on Wednesday November 30th. The agenda can be found here: http://www.morristwp.com/agendas/twpcomm_11-11-30.pdf

There was very little on the agenda at this meeting, which is usually the case towards the end of any calendar year. This is because most legislation for the year has already been wrapped up. New legislation cannot be introduced in one calendar year and approved in another calendar year, because the voting composition of the Township Committee can change.



There was one ordinance (added at the last minute) for introduction and no ordinances up for final adoption. The ordinance introduced was:

37-11 AN ORDINANCE AMENDING CHAPTERS 57 and 95 OF THE CODE OF THE TOWNSHIP OF MORRIS, TO PERMIT COMMERCIAL FARMS AND FARMING ACTIVITY IN CONFORMANCE WITH THE RIGHT TO FARM ACT. (To be referred to the Planning Board for review and comment.) – Scheduled for public hearing and final consideration – 12/14/2011

During the "Public Comment" portion of the meeting, three residents came up to the microphone to discuss various issues:

- The first resident spoke about speeding along Western Avenue and asked if the Township could reduce the speed limit to 25 miles per hour.
- The second resident asked if the Township had received any updates from JCP&L about

their internal investigations relating to the prolonged power failures during the two recent storms. He was told that the Township would be meeting with JCP&L in early December.

- The third resident noted a newspaper article stating that the corporate offices for Realogy Corp. would be moving from Parsippany to a new building at 175 Park Avenue, bringing approximately 950 employees to the already congested corridor of Park Avenue. The resident noted that BASF Corp. is also moving into offices along Park Avenue, and he wanted to make sure that these additional traffic impacts would be considered by the Planning Board as they examine the development plans for the Honeywell property in Morris Township.

The next Township Committee meeting will be on Wednesday December 14th at 8:00pm at our municipal building.

Planning Board to Hear Honeywell "Mixed-Use" Proposal

At their upcoming meeting this Monday, the Planning Board had planned to discuss an amendment to the township's Master Plan that would create zoning to allow Honeywell International to build a mixed-use development (including office and residential buildings) on its 147-acre property at Columbia Turnpike and Park Avenue in the northeast quadrant of the township. Morris County to Fund 12 Open Space Projects

The Morris County Board of Chosen Freeholders on Nov. 9 approved spending \$11,626,750 from the county's Preservation Trust Fund to help preserve 1,286.5 acres of open space in 11 towns. The freeholders approved funding 12 projects based upon the recommendations of the county's Open Space Trust Fund Committee. See the entire press release here:

A portion of the tax of 1 ½ cents per \$100 of assessed property value was used to fund the 2011 program. Morris County voters approved the program in November 1992. Since the Preservation Trust Fund's inception, 543 projects have been completed in 38 of the county's 39 towns, and more than 20,000 acres of land in the county have been permanently preserved.

Any of the 39 municipalities in the county and qualified charitable conservancies are eligible to



apply for project funding. Unfortunately, Morris Township has not received any open space funding from the county program in several years.
