### **Township Annual Reorganization Meeting on Jan. 4**

The meeting continued with the announcements of all appointments to our various Boards and Committees. Several dignitaries were on hand including State Senator Anthony Bucco, and Assemblymen Anthony Bucco and Michael Carroll, as well as former State Senator Gordon MacInness.

### **Township Committee Regular Meeting on Jan. 18**

The January 18 meeting opened with the swearing-in of a new firefighter Steve Cornine, who is replacing a retiree.

Firefighter Cornine was introduced by Fire Chief Scott Lovenberg and sworn in by Township Attorney John Mills. Steve is a Morris Township resident and has been a volunteer firefighter for the Fairchild Fire Department for many years. He is very well qualified and a welcome addition to our wonderful crew of professional firefighters.



There were two ordinances up for introduction and none for final adoption (as this was the first meeting of the year none had been previously introduced). The following ordinances will be up for approval and final adoption at the February 15 meeting:

**01-12 "AN ORDINANCE OF THE TOWNSHIP OF MORRIS, MORRIS COUNTY, NEW JERSEY, CONCERNING SALARIES FOR MEMBERS OF MORRIS COUNTY COUNCIL NO. 6, NJCSA, IFPTE, AFL-CIO"**

**2-12 AMENDING CHAPTER 95, ZONING-OF THE CODE OF THE TOWNSHIP OF MORRIS RE: 95-54. C. OFF-STREET PARKING REQUIREMENTS FOR PARTICULAR USES (THIS ORDINANCE WAS REMANDED TO THE PLANNING BOARD OF THE TOWNSHIP OF MORRIS FOR REVIEW AND RECOMMENDATIONS)**

The resolutions voted upon can be found by clicking on the above link to the agenda. Both resolutions were successfully adopted.

During the "Public Comment" portion of the meeting, six residents came up to the microphone to discuss various issues:

- The first resident brought up several subjects:
  1. He complained that light posts on his street had fallen down in the past few months, and requested the Township Committees help in getting JCP&L to replace them.
  2. He asked about the Township vehicle auction held earlier in January (where the Township auctioned off 16 very old vehicles that were no longer in use)
  3. He mentioned that he had read an article about municipalities pooling their electricity purchases and asked if the Township was participating in such pooled energy contracts. (He was told that last year the Township negotiated its own energy contract which has resulted in significant savings on our electrical bills in just the first six months of the contract)
- The second resident brought to the attention of the Township Committee the continuing lack of attention to a dilapidated fence that runs along Deborah Drive across from the failed townhouse development which is responsible for maintaining the fence. He was told that the Township would be using monies from the developer's performance bond to replace the fence and that the engineering department would be setting up a neighborhood meeting shortly.

As is the normal order of business, the Township Committee commentary followed the public commentary. As noted above, this year I will be posting my comments online so that they are publicly available: <http://www.jeffgrayzel.com/committee-comments.html>

In addition to my prepared remarks I made a request of the Mayor that in light of the Honeywell development proposal before the planning board that the Township Committee hold a public review of the role the Township Committee plays in the land-use planning and land-use ordinance approval processes. I stated that the public needs to have a thorough understanding of the process of adopting land-use regulations and ordinances in our municipality given the expectation that this body would soon be handed a master plan amendment by the Planning Board. Mayor Mancuso agreed to make this a formal agenda item at our February 15 meeting. To members of the public who wish to have a better understanding of our land-use planning and ordinance approval processes: I suggest you attend the February 15 meeting. **Note:** This will be a generic discussion of the approval processes and there will be absolutely no discussion of the specifics of the Honeywell development plan, which is still under purview of the Planning Board.

**Planning Board releases draft Master Plan Amendment for Honeywell and schedules public commentary for February 5th**

At its January 9th meeting, the Planning Board discussed a draft amendment to the Township’s Master Plan to enable mixed-use development at the 147-acre Honeywell property on Columbia Turnpike and Park Avenue. A newly created zone would allow hundreds of town houses, retail space, office buildings, and a 400-unit CCRC on a subdivision of the Honeywell tract.

### Tips for Preventing Home Break-ins

The following tips were passed along to me so I thought I would share them with you. The following are some suggestions that you may wish to follow, even if you are not away:

1. Pick up your newspapers.
2. Take in your garbage cans -- don't leave them out for days.
3. Don't leave mail in the mailbox.
4. Set timers in your house, and have them go on prior to it getting dark (you can now by light timers that are light sensitive so they automatically turn on at dusk when the light gets low). This makes the house appear to be occupied.
5. Use motion sensor lights - especially in the rear of the house. Higher lights are always better as they cannot be easily dismantled. Make sure lower windows are locked, especially in the garage. Trim shrubs near doors and windows. Make sure your house number is visible from the road.
6. Let your trusted neighbors know when you are away.
7. Don't post pictures of you away on vacation on your social media sites. "checking-into" places is always a sure giveaway.
8. Keep pictures of your prized possessions. Write down serial numbers. Keep appraisal reports. Engraving is always a good identifier. Some even periodically video their house to remember what they have. The police do a good job tracking/ informing the pawnshops of the stolen jewelry.
9. If you see a suspicious car, don't hesitate to call the police. If you are unsure, at the very least, do your best to write down the make, model and color-description of driver/passengers. Getting a license plate is always best.
10. Consider notifying the township police about being away on vacation or at a family funeral. The police may be able to make random checks of the property.

The law requires that all general-purpose bulbs be more energy-efficient and that 100-watt incandescent bulbs be phased out by the end of 2012. 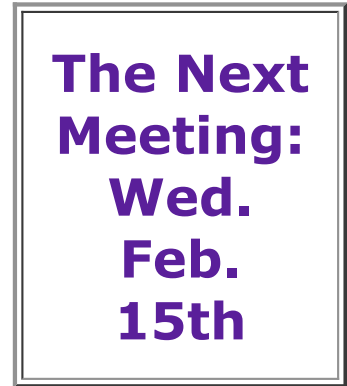
