However, I did want to inform you of an important meeting taking place this Wednesday May 16 when the Township Committee will be presenting the annual municipal budget at a public hearing.

**Township Committee to present
Annual Municipal BUDGET this Wednesday May 16th**

At their regular meeting tomorrow the Township Committee will be voting on the annual municipal budget. Prior to the vote there will be a presentation by Mayor Mancuso that will provide an overview of the budget and its implications. Following the presentation will be a Question & Answer period where residents may ask any question or make comments related to the budget.

**Planning Board to continue public comment session
for draft Master Plan Amendment for Honeywell on May 17**

The Planning Board has been accepting public commentary on the draft amendment to the Township's Master Plan at recent meetings on March 5, April 2, and April 19, 2012. This amendment would enable mixed-use development at the 147-acre Honeywell property on Columbia Turnpike and Park Avenue. A newly created zone would allow hundreds of town houses, retail space, office buildings, and a 400-unit CCRC on a subdivision of the Honeywell tract. The

Planning Board will continue to hear public comments at their upcoming meeting on May 17.

- New Jersey's [Department of Environmental Protection](#) recently urged citizens to conserve as much water as possible. Despite the flooding last year and the nor'easter earlier in the spring, New Jersey is experiencing a rainfall deficit thanks to a dry winter and an equally dry start to the spring season. In fact, here in Morris County, rainfall amounts stand at 5.8 inches BELOW normal (as of a couple of weeks ago). So I urge everyone to start conserving water in any manner they can.
