Dear Neighbors,

Today, I am writing to you about an important local election in Morris Township this Tuesday. Some other news of interest follows at the bottom of this e-mail.

**General Election on November 2**

Let me again remind you of how our local government works. We have one of the seven different forms of government allowed in the state of New Jersey. Morris Township is governed by a Township Committee of five members. We do not have an elected Mayor, such as in Morristown and Morris Plains. Rather our Mayor is an appointed position from one of the five Committee members. With no elected Mayor to counter-balance the Committee, the only check & balances that we have has to come from within the Township Committee itself.



Ron Goldberg is finishing up his first 3-year term on the Township Committee and is up for re-election. As the lone Democrat on a Committee with four Republican members, Ron has been providing the little bit of "balance" we find in our local government. He is our "checks & balances" against the block of 4 other Committeemen.

Goldberg has worked hard for the residents of Morris Township. Here are just a few of his many accomplishments:

- 2010 appropriations were reduced by \$1 million compared to 2009
- He worked with unions to get give-backs to help balance our budget
- He identified weak management reports and tools
- He showed the need for a local anti-pay-to-play law
- He kept our parking, sewer and pool utilities solvent to avoid a tax payer subsidy.

If you have ever met Ron you would know that he operates in a non-partisan fashion and just tries to do what is best for Morris Township. He works, hard, does his homework, and is

accessible to you. He is always looking out for the best interest of ALL residents of our community.

Goldberg's opponent is Peter Mancuso. I would like to provide you with 3 facts about Mancuso, and you can see if you come to the same conclusion as I do about his candidacy:

**1.** The Morris Township Carnival had to shut down in the Spring of 2007 while under investigation by the State of New Jersey. Mancuso was President of the carnival from 1990-2007. Mancuso mismanaged the finances of the corporation he headed by failing to meet federal and state-level filing requirements for at least SIX consecutive years, 2001-2006. During those years, the Mancuso-led carnival was not a legitimate corporation, and was not following the rules set down for tax exempt corporations.

**2.** Mancuso recently sent out a campaign brochure talking about the so-called scholarship money he distributed while president of the (defunct) carnival. In the brochure, Mancuso uses a stock photo of kids from Canada -- yes, that country up north -- saying "Thank You Mr. Mancuso". You can see the photo here:

The whole thing is disingenuous. We still don't know whether the scholarships from the carnival, which was named after our Township, run from Township government offices, cited on Township owned fields and supported by Township residents' money, actually benefited the families of Morris Township. The public knows little of the selection process and none of the selectees. Who got the money? Last week, Mancuso finally disclosed a settlement letter from the IRS and two letters from local colleges dated October 2010. Apparently when the whistle blew in 2006, he was motivated to back-file. However, he has never shown the public any audits or how he satisfied New Jersey state officials yet. He has not apologized to you for embarrassing Morris Township with scandal.

**3.** I have told you that I continue to attend our Township Committee meetings regularly, I can tell you that Mr. Mancuso has missed 2 of the past 4 meetings leading up to the election, including the most recent meeting on October 20 (the last one before the election!). To me, this shows a true lack of interest and commitment. And prior to his candidacy this year (and for many prior years) Mancuso sightings at Township Committee meetings were extremely rare. Contrast this with Ron Goldberg who attended over 100 public Township meetings before being elected so he would be prepared for office.

**Ron Goldberg is by far the better choice for our Township Committee. I am putting my support behind Ron Goldberg and hope you do too.**
