## **Township Committee Meeting on Nov. 9**

The Township Committee held a regular meeting on Wednesday November 9th.

The meeting opened with a badge ceremony for a new firefighter. New firefighter SEAN McCLOSKEY was sworn in by Fire Chief Scott Lovenberg.



The meeting then continued with four ordinances up for adoption and two ordinances for introduction (with final adoption at the next meeting) as follows:

- **32-11 AN ORDINANCE AMENDING CHAPTER 88, SECTION 2.2 AND SCHEDULE I "NO PARKING ANY TIME." (adopted)**
- **33-11 AN ORDINANCE AMENDING ORDINANCE 29-11 ESTABLISHING SALARIES AND COMPENSATION FOR EMPLOYEES OF THE POLICE SUPERIOR OFFICER'S ASSOCIATION (PBA 133A) OF THE TOWNSHIP OF MORRIS. (adopted)**
- **34-11 AN ORDINANCE DEDICATING A PORTION OF LANDS OF THE TOWNSHIP OF MORRIS FOR ROADWAY AND OPEN SPACE PURPOSES – WHITE BIRCH ROAD. (adopted)**
- **16-11 ADDING SECTION 57-166, DEVELOPMENT FEES FOR AFFORDABLE HOUSING, TO CHAPTER 57, LAND DEVELOPMENT (re-introduced)**
- **35-11 AN ORDINANCE ADDING A NEW CHAPTER ENTITLED "REPAIR OR REPLACEMENT OF MAILBOXES" WHICH IS PROVIDING FOR REIMBURSEMENT FOR DAMAGE OCCURRING TO MAILBOXES IN THE TOWNSHIP OF MORRIS" (introduced)**
- **36-11 AMENDING CHAPTER 15, SECTION 7 ENTITLED VACATIONS AND HOLIDAYS BY ADDING SUBSECTION A(i) AND A(II). (introduced)**

A number of bills were paid related to Hurricane Irene damage. One of these bills paid was to PM Construction in the amount of \$103,246.69 for repairs on Lake Valley Road. I mention this one example so that residents understand the significant costs incurred by the Township as a result of two major storms.

During the "Public Comment" portion of the meeting, five residents came up to the microphone to discuss issues and ask questions of the Township Committee. Four residents relayed their experiences during the power outage as a result of the snowstorm. They were concerned that their section of town (Mountainside Drive) was last to be restored in each of the two outages. Another spoke of the Watnong Brook.

The next Township Committee meeting will be on Wednesday November 30th at 8:00pm at our municipal building.

## **JCP&L and BPU**

JCP&L's internal self-assessment is continuing. They will be providing a status report to the Township in the near future.

As stated in my last newsletter, I encourage you to communicate any complaints or concerns you may have to the NJ Board of Public Utilities. The BPU regulates all utilities in the state, and those utilities "report" to BPU (not to the individual municipalities). ### **Morris Township and Morristown settle sewer dispute**

Morristown and Morris Township settled their dispute over which municipality should get the connection fees for the new Egbert Ave. sewer line Morris Township installed and paid for. Under a contract, the Morris Township sewer utility takes the flow from this line that serves Town and Township homes. However, the contract does not clearly state how the costs of the new lines and fees from new hookups should be distributed. When Morris Township collected the hookup fees, Morristown threatened to sue individual home owners for return of the fee. Apparently, the Morris Township governing body decided settlement would be best, so that the residents would be out of the middle and high legal costs could be avoided. The connection fees were split, although they are usually used to offset construction cost, and total construction cost has been borne by the Township.
