## October 2014: Morris Township News Update

## Township Committee Meetings of August and September

The Township Committee held their last two monthly meetings on August 27, 2014 and September 17. The agendas for both of these meetings can be found here:

The August meeting opened up with a special presentation to Dr. Thomas Ficarra, the retiring superintendent of the Morris School district.



In **August**, there were ordinances up for final adoption:

- **16-14:** ACCEPTING DEED OF DEDICATION; LANDS AND PREMISES KNOWN AS BLOCK 3202, LOT 6  
*This ordinance accepts a deed for a property located on Whitehead Road. This property was recently sub-divided by the SMCMUA for the purpose of donating some land for Open Space. The house on the remaining parcel will now be put up for sale.*
- **17-14:** ORDINANCE AMENDING SECTION 3(i) OF BOND ORDINANCE NO. 08-13 FINALLY ADOPTED MAY 15, 2013 IN ORDER TO REVISE THE DESCRIPTION OF THE IMPROVEMENT THEREIN IN AND BY THE TOWNSHIP OF MORRIS  
*This ordinance amends a prior ordinance relating to road improvement funding to now include the repaving of Kitchell Road.*
- **18-14:** ORDINANCE APPROPRIATING \$500,000 AVAILABLE IN THE SEWER UTILITY CAPITAL FUND BALANCE TO PROVIDE FOR THE REPLACEMENT OF THE SAND FILTER SYSTEM AT THE BUTTERWORTH SEWER PLANT IN AND BY THE TOWNSHIP OF MORRIS  
*This ordinance appropriates available funds in the Sewer Utility Capital Fund to be used to upgrade the Butterworth Sewer Plant with a new sand filter system.*

In **September** there were three ordinances up for final adoption:

- **19-14:** ORDINANCE OF THE TOWNSHIP OF MORRIS, IN THE COUNTY OF MORRIS, NEW JERSEY AUTHORIZING A SPECIAL EMERGENCY APPROPRIATION IN THE AMOUNT OF \$800,000 FOR A PROGRAM OF REVALUATION OF REAL PROPERTY IN, BY AND FOR THE TOWNSHIP  
*This ordinance appropriates \$800,000 for the revaluation of all properties (both residential and commercial) in Morris Township. This revaluation was mandated by the Morris County Tax board. The process will take place this coming year and new valuations will be in affect for the 2016 tax bills.*
- **20-14:** ORDINANCE AMENDING CERTAIN BOND ORDINANCES AND REAPPROPRIATING PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSES IN ORDER TO PROVIDE FOR VARIOUS OTHER PURPOSES REFERRED TO HEREIN IN AND BY THE TOWNSHIP OF MORRIS (GENERAL)  
*This ordinance re-appropriate unspent appropriated funds from past general capital improvements have been completed. The funds will be used for projects outlined in the ordinance.*
- **21-14:** ORDINANCE AMENDING CERTAIN BOND ORDINANCES AND REAPPROPRIATING PROCEEDS OF OBLIGATIONS NOT NEEDED FOR THEIR ORIGINAL PURPOSES IN ORDER TO PROVIDE FOR VARIOUS OTHER PURPOSES REFERRED TO HEREIN IN AND BY THE TOWNSHIP OF MORRIS (SEWER)  
*This ordinance re-appropriate unspent appropriated funds from past sewer utility capital improvement projects that have been completed. The funds will be used for projects outlined in the ordinance.*

At both the August and September meeting, the Township Committee followed ordinance actions with votes on a long list of resolutions relating to various matters. You can review all of the ordinances and resolutions passed by the Township Committee by viewing the link above that will take you to the Township's "agenda center" on our municipal website.

Each meeting has a portion for public commentary when residents can stand up to ask questions of the Township Committee or make statements about Township business or matters relating to the community. In September, a member of the public made a notable suggestion to the Township Committee. She made a case for televising Township Committee meetings. She pointed out that virtually every other municipality in the area broadcasts their meetings in one form or another (either on cable TV or over the internet), that broadcasting can be done at little or no cost to government, that it builds community, appreciation for government service, and trust in government by adding transparency and understanding. She called it "win-win" for residents and local government. She presented the Committee a document on which almost 400 residents expressed interest in TV broadcast of meetings. She asked the Committee members what their position was on televising our meetings. I am the only one who supported it. TV broadcast is something I myself had urged in the past. The other four Committeemen dismissed it as having no interest to our residents and being very low priority to our government.

The Township Committee concluded the meeting with commentary from each member of the Committee. My public commentary is posted to my website so that they are publicly available.

## Flu Season has Begun and Enterovirus Hits New Jersey

October 1 marked the official beginning of flu season in New Jersey. I wanted to pass on some information and also recommend you visit the NJ Department of Health's website: <http://www.nj.gov/health/flu/generalinfo.shtml>



Here you can get information on:

- What you need to know to stay healthy during flu season
- Tips to take care of yourself and others, should you get the flu
- When children should stay home from school
- How to distinguish the flu from a cold.
- Also, you can access the "Find a flu shot" locator at <http://www.nj.gov/health/flu/findflushot.shtml> By just entering a zip code, you can use this tool to learn the locations for inoculations that are closest to you.
- You will also find a link to the Centers for Disease Control (CDC) Seasonal Flu website (<http://www.cdc.gov/flu/>), which includes some excellent free educational resources, including printed material, podcasts and PSAs.
- At the Department's website, you can also access information on the threat posed by Enterovirus D68 (EV-D68). As of October 1, there were seven laboratory confirmed case of the disease (which has already killed four people, nationwide) in the Garden State. According to the CDC, 443 cases of EV-D68 have been confirmed in 40 states and the District of Columbia since mid-August.

- **Morris Township offers flu shots:** Morris Township Health Department is hosting a Seasonal Flu Clinic. It will take place at the Morris Township Municipal Building at 50 Woodland Avenue on Monday October 20, 2014 from 1:00 PM – 3:00 PM

This clinic is open to all residents of Morris Township and to children who attend school or child care in Morris Township. The vaccine is Free for all who have Traditional Medicare B (be sure to bring your Medicare Card with you). For those with a Medicare HMO, or no Medicare B the cost is \$ 25.00

The Parks and Recreation Department also offers ongoing activities for our experienced 60 plus residents including bus trips, exercise classes, bocce, bingo, card parties, and special events co-sponsored by the Morris Township Senior Citizen's Club.

The brochure also offers a comprehensive guide identifying all of the Township's active recreation sites, and important contact information for the many local sports and recreation organizations that provide activities for residents of the area.

- **5 Months of Deer Hunting Coming to County Parks in Morris County:** County-wide management program to allow hunting on various parks in Morris Township.

In an effort to cull white-tailed deer and "minimize severe threats posed to the biodiversity of native flora and fauna," the Morris County Park Commission is continuing its annual deer management program and has released a hunting schedule.

That schedule includes a total of 21 weeks of active hunting allowed in six county-owned parks that are either all or partially in the Morris Township area. The Morris County Park Commission is responsible for the stewardship of over 18,000 acres of land. It recognizes that a controlled hunting program is the most efficient and effective way available to minimize the severe threats posed to the biodiversity of native flora and fauna by overabundant white-tailed deer populations.
